1. 根據《選舉管理委員會（選舉程序）（立法會）規例》（第541D章）第105條及《立法會選舉活動指引》第八章，候選人須在發布選舉廣告後的一個工作天內（即公眾假期及星期六以外的任何一天），把與選舉廣告有關的資料／文件，包括准許或同意書的電子文本，上載至中央平台或候選人平台或向選舉主任繳存其印本式文本，以供公眾查閱。

In accordance with section 105 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D) and Chapter 8 of the “Guidelines on Election-related Activities in respect of the Legislative Council Election”, the candidate must, **within 1 working day** (i.e. any day other than a general holiday and Saturday) after publication of an election advertisement, post an electronic copy of the relevant information/document, including permission or consent, onto the Central Platform or Candidate’s Platform or deposit a hard copy with the Returning Officer for public inspection.

Purpose of Collection

The personal data and other related information supplied in connection with this permission will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the relevant Returning Officer and other related government departments for election-related purposes.

(b) **資料轉介**

Transfer of Information

All telephone numbers in the permission will be covered before display. The personal data and other related information supplied in connection with this permission may also be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.
