If *I am/we are so removed, *I/we may not re-enter the counting station/ballot paper sorting station except with the permission of the Chief Returning Officer, the Returning Officer or the Presiding Officer.

Notes on Completion of Notice of Appointment of Counting Agents for a Geographical Constituency

- 除非候選人以指明表格明文另作示明,有關代理人須當作是為在預定日期進行的投票中和(如適用的話)於遭押後的該次投票中所投的票的點算而委任。
 - The agent is to be regarded as being appointed for the counting of the votes cast in the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate expressly indicates otherwise in the specified form.
- 2. 候選人或其選舉代理人可就中央點票站、每個點票分流站及在該候選人獲提名的地方選區內每個點票站各<u>委任不超過2名監察點票代理人</u>。凡年滿18歲的香港身分證持有人均可被委任為監察點票代理人。候選人或其選舉代理人不應委任任何總選舉主任、選舉主任、助理選舉主任、或任何已受總選舉事務主任委任協助進行投票或點票的人士(通常為政府公職人員)為其監察點票代理人。
 - A candidate or his/her election agent may <u>appoint not more than 2 counting agents</u> for the central counting station, each ballot paper sorting station and each counting station in respect of the geographical constituency for which he/she is nominated. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a counting agent. A candidate or his/her election agent should not appoint any Chief Returning Officer, Returning Officer, Assistant Returning Officer, or any person (usually a government officer) already appointed by the Chief Electoral Officer to assist at the poll or at the count as the counting agent.

 - PART I of this notice should be completed and signed by the candidate or the election agent. PART II should be completed and signed by each of the counting agents.
- 4. 監察點票代理人的委任通知書,須於投票日前的第7天或之前(即2018年3月4日或之前)藉專人送遞、郵遞、電子郵件或圖文傳真方式交付予有關的選舉主任,或於投票日由候選人或選舉代理人 親自交付予監察點票代理人所負責的點票站/選票分流站的投票站主任(如該等監察點票代理人所 負責的是中央點票站,則須交付予有關的選舉主任)。逾期遞交的通知書將不予接納。監察點票代 理人的委任,在選舉主任或投票站主任(視何者屬適當而定)接獲委任通知書後始生效。
 - Notice of appointment of counting agents must either be delivered to the relevant Returning Officer by hand, by post, by electronic mail or by facsimile transmission at least 7 days before the polling day (i.e. on or before 4 March 2018), or be delivered by the candidate or the election agent in person to the Presiding Officer for the counting station/ballot paper sorting station for which the counting agents are appointed on the polling day (or to the relevant Returning Officer if the counting agents are appointed for the central counting station). Late submissions will not be accepted. The appointment of counting agents will not be effective until the notice of appointment is received by the Returning Officer or the Presiding Officer, as may be appropriate.

Purpose of Collection

The personal data and other related information supplied in connection with this notice will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the Chief Returning Officer, the relevant Returning Officer and the Presiding Officers for the relevant polling stations/counting stations/ballot paper sorting stations and other related government departments for election-related purposes.
