The Chinese characters “選舉郵件” or “選舉廣告” or words “Election Mail” or “Election Advertisement” \*will be / have been printed on the address (front) side of the envelope or the address side of the folder (for unenveloped mail).

我現謹作以下聲明並明白：

I hereby declare and understand that :

- (a) 郵件只載有與候選人參選這次補選相關的物料；  
the mail contains materials relating only to the candidature of the candidate at this by-election ;
- (b) 郵件重量不超過 50 克；  
the mail does not exceed 50 grams in weight;
- (c) 郵件尺碼不大於 175 毫米乘以 245 毫米，但不小於 90 毫米乘以 140 毫米；  
the mail is not larger than 175 mm x 245 mm and not smaller than 90 mm x 140 mm in size;
- (d) 如果選舉郵件中收納了某人士或組織的姓名、名稱、標識或圖像 (視屬何情況而定)，而發布的方式意味着或相當可能導致選民相信本通知書所提述的候選人已獲得該人或該組織的支持，候選人已事先取得該人或該組織的書面同意；  
If the name, logo or pictorial representation of a person or an organisation, as the case may be, is included in the election mail, and the publication is in such a way as to imply or to be likely to cause electors to believe that the candidate mentioned in this Notice has the support of the person or organisation concerned, the candidate has obtained prior written consent from the person or organisation concerned;

The contents of the specimens are in full compliance with all applicable laws and the “Guidelines on Election-related Activities in respect of the District Council Election”;

If the enclosed specimens of the election mail contain any content in a language other than Chinese and English, I hereby enclose the \*Chinese/English translation of such content in order to ensure it complies with paragraphs (a) and (e) of this declaration; and
- (g) 選舉管理委員會及香港特別行政區政府 (包括香港郵政及選舉事務處) 對候選人及任何第三者概不就選舉郵件承擔任何責任，包括但不限於因選舉郵件內容的任何錯誤、遺漏、虛假或具誤導性的陳述而引致的法律責任。投寄選舉郵件的候選人必須為選舉郵件及其內容承擔一切責任，並須就選舉郵件及其內容所引致或涉及的一切法律責任、費用、開支、法律行動、法律程序、申索、要求、損失及損害賠償，向選舉管理委員會及政府作出彌償，並保持令其獲得彌償。

The Electoral Affairs Commission and the Government of the Hong Kong Special Administrative Region (including Hongkong Post and the Registration and Electoral Office) shall not be responsible to the candidate or any third party for the election mail, including but not limited to any liabilities arising from any errors in, omissions from, false or misleading statements in the contents of the election mail. The candidate posting the election mail shall be responsible for the election mail and its contents, and shall indemnify and keep indemnified the Electoral Affairs Commission and the Government against all liabilities, costs, expenses, actions, proceedings, claims, demands, losses and damages arising out of or in connection with the election mail and its contents.
