應根據於中央平台或候選人平台或交給選舉主任之「選舉廣告資料摘要」(表格編號: REO/C/10/DC(SF)(2017))及「修正選舉廣告資料摘要通知書」(表格編號: REO/C/11/DC(SF)(2017))(如適用)所列的選舉廣告數量及種類, 計算及填寫此部分之開支。不論開支的價值是否極少, 候選人均須申報每一項選舉廣告的開支。即使某項選舉廣告的開支為零, 候選人亦應申報該項目, 以供選舉事務處查核。

The expenses entered in this section should be calculated based on the quantities and types of election advertisements as stated on the Central Platform or Candidate's Platform or in the "Information Sheet in Relation to Election Advertisements" (Form no.: REO/C/10/DC(SF)(2017)) and "Notification of Corrected Information in Relation to Election Advertisements" (Form no.: REO/C/11/DC(SF)(2017)) (if applicable) submitted to the Returning Officer. The candidate should declare the expenses for each and every item of election advertisement no matter how minimal the value of the expense is. Even if the expense for a particular election advertisement is zero, the candidate should also declare the item for checking by the Registration and Electoral Office.
