Notes on Completion of Advance Return and Declaration of Election Donations

1. 在填寫此申報書及聲明書前，請閱讀《選舉（舞弊及非法行為）條例》（第 554 章）及選舉管理委員會發出的《區議會選舉活動指引》第十五章。
Please read the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and Chapter 15 of the “Guidelines on Election-related Activities in respect of the District Council Election” issued by the Electoral Affairs Commission before completing this return and declaration.

 - (c) any service provided to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, but does not include voluntary service.
