填寫候選人退選通知書說明

Notes on Completion of Notice of Withdrawal of Candidature

1. 獲提名而欲退出選舉的候選人，須填寫本通知書。通知書須由候選人於見證人在場下簽署。任何年滿 18 歲並持有身分證明文件的人士，均可擔任見證人。根據《區議會條例》（第 547 章）第 2 條，“身分證明文件”（identity document）指—

This notice must be completed by a nominated candidate who wishes to withdraw his/her candidature. It must be signed by the candidate in the presence of a witness who can be any person aged 18 years or over and in possession of an identity document. According to section 2 of the District Councils Ordinance (Cap. 547), “identity document” (身分證明文件) means –

- (a) 根據《人事登記條例》（第 177 章）向某人發出的身分證；或
an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177); or
- (b) 《人事登記條例》（第 177 章）第 1A(1)條所指的人事登記處處長向某人發出的文件，而該文件證明該人根據《人事登記規例》（第 177A 章）第 25 條獲豁免，無須根據該條例登記；或
a document issued by the Commissioner of Registration (within the meaning of section 1A(1) of the Registration of Persons Ordinance (Cap. 177)) to a person certifying that the person is exempt, under regulation 25 of the Registration of Persons Regulations (Cap. 177A), from being required to register under that Ordinance; or
- (c) 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person’s identity.
2. 本通知書第二部分須由見證人填寫及簽署。
The witness is required to complete and sign PART II of this notice.
3. 填妥的通知書須於提名期結束前（即 2019 年 10 月 17 日或之前）由候選人或候選人的選舉代理人親自送遞予有關選區的選舉主任。在該日期後，將不接受退選。選舉主任的地址已在憲報刊登。
The duly completed notice must be delivered to the Returning Officer for the relevant constituency by the candidate or the candidate’s election agent in person before the end of the nomination period (i.e. on or before 17 October 2019). Withdrawal will not be accepted after that date. The address of the Returning Officer has been specified in the Gazette.

(a) **資料用途**

就此通知書提供的個人及其他有關的資料，會供選舉管理委員會、選舉事務處、有關選區的選舉主任及其他有關的政府部門用於與選舉有關的用途。

Purpose of Collection

The personal data and other related information supplied in connection with this notice will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the Returning Officer for the relevant constituency and other related government departments for election-related purposes.

(b) **資料轉介**

此通知書會根據《選舉管理委員會（選舉程序）（區議會）規例》（第 541F 章）第 14 條供公眾查閱直至有關的選舉結果於憲報刊登為止。在展示前，通知書內所有身分證明文件號碼及見證人住址將會被遮蓋。就此通知書提供的個人及其他有關的資料亦可能會提供予其他獲授權的部門或人士，包括但不限於法院，用於與選舉有關的用途。

Transfer of Information

This notice will be made available for public inspection in accordance with section 14 of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F) until the relevant notice of election result is published in the Gazette. All identity document numbers and witness’ residential address in the notice will be covered before display. The personal data and other related information supplied in connection with this notice may also be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).
