The provision for 2025-26 under the Registration and Electoral Office (REO) for the preparation and conduct of the 2025 Election Committee Subsector (ECSS) By-elections and the 2025 Legislative Council General Election (LCGE) is about \$1.513 billion (including the preparation and conduct of the 2025 voter registration cycle and relevant work), with breakdown as follows:

2. The REO preliminarily estimates that it will need to recruit about 38 500 government employees to participate in the various electoral work for the above two elections.

3. The provision for 2025-26 for the preparation and conduct of the 2025 LCGE is about \$1.28 billion (including the provision for the preparation and conduct of the 2025 voter registration cycle and relevant work). This represents an increase of about 52% over the expenditure for the preparation and conduct of the 2021 LCGE in 2021-22 which was about \$841 million (including the provision for the preparation and conduct of the 2021 voter registration cycle and relevant work). The increase is mainly due to publicity expenses, expenditure on information technology support, rental cost of polling station venues, as well as staff remuneration, etc.

In the past 5 years, the establishment and expenditure of the Voter Registration Division responsible for voter registration matters under the Registration and Electoral Office (REO) are tabulated below:

2. After improving the electoral system, the REO normally launches the Voter Registration Campaign in April every year. The deadline for submitting applications for new registration/report on change of particulars is set on 2 June every year. The publicity expenses for the Voter Registration Campaign in the past 3 years are tabulated below:

3. In line with the improved electoral system, the REO has been applying information technology (IT) more extensively in elections in recent years. In addition to using the Electronic Poll Register System for issuing ballot papers and the Electronic Vote Counting System to assist in vote counting, the REO has continuously applied IT in other electoral processes to enhance efficiency and introduce more user-friendly arrangements. For example: (1) enhancing the Online Voter Information Enquiry System to enable voters to log in the system through "iAM Smart", and submit applications for new registration or report on change of registration particulars by an elector in a geographical constituency, etc. via "iAM Smart+" so as to facilitate voters; (2) utilising the Electronic Platform for Recruitment of Electoral Staff and the E-sign in/sign out System for Electoral Staff to optimise the recruitment. management and attendance record arrangements for electoral staff; (3) launching the Polling Station Management System to monitor the progress of delivering electoral materials to polling stations before the election and support the replenishment of materials on the polling day; and (4) launching the Mobile Input System for Electoral Statistics to enable polling and counting staff to input, calculate and verify various electoral data of polling and counting stations and upload such data to the Statistical Information Centre of the REO on the polling day in a more convenient and efficient manner, so as to make the data collection process more efficient and accurate. The expenditures on the administration and maintenance of the systems (including the staff costs) are part of the REO's recurrent expenditure and thus cannot be itemised separately.

In addition, there will be a net decrease of 4 posts in 2025-26. In this connection, please inform this Committee of the following:

- the estimated expenditures and manpower arrangements for the 2 elections, the reasons for proposing the earmarked provision, and whether other methods such as technology will be adopted to reduce costs and enhance efficiency;
- (2) the details regarding the net decrease of 4 posts in 2025-26;
- (3) the Administration has stated that publicity work for future public elections will be conducted through various "innovative, diversified and down-to-earth" means, so as to encourage the public to vote in the Legislative Council election. What are the innovative measures for promoting elections in the context of a fiscal deficit?

The provision for 2025-26 under the Registration and Electoral Office (REO) for the preparation and conduct of the 2025 Election Committee Subsector (ECSS) By-elections is about \$233 million and the provision for the preparation and conduct of the 2025 Legislative Council General Election (LCGE) is about \$1.28 billion (including the provision for the preparation and conduct of the 2025 voter registration cycle and relevant work).

2. The REO preliminarily estimates that it will need to recruit about 1 500 and 37 000 government employees to participate in the electoral work for the 2025 ECSS By-elections and the 2025 LCGE respectively.

3. The above mentioned provisions are to ensure the smooth conduct of the two elections, ensuring that the elections will be fair, just and honest, as well as safe, orderly, efficient and user-friendly. In respect of election publicity, the REO is dedicated to launching diversified and extensive publicity activities to promote public understanding of and support to the elections, thereby creating a lively election atmosphere which will encourage electors to vote actively.

4. The REO has been applying information technology (IT) more extensively in the elections in recent years. In addition to using the Electronic Poll Register system for issuing ballot papers and the Electronic Vote Counting System to assist in vote counting, the REO has also applied IT in other electoral processes. Examples are launching the Polling Station Management System to monitor the progress of delivering electoral materials to polling stations before the election and support the replenishment of such materials on the polling day; and introducing the Mobile Input System for Electoral Statistics to enable polling staff to conveniently and effectively input, calculate, validate and submit various electoral data. The REO will, having regard to the actual circumstances and need, continue to promote the application of IT to enhance efficiency and make elections more user-friendly.

5. As at 31 March 2025, the REO's establishment consists of 320 posts and it is anticipated that 2 additional civil service posts (including 1 Senior Systems Manager and 1 Systems Manager posts) will be created in 2025-26. Question:

- (1) The estimated expenditure of the Registration and Electoral Office (REO) for 2025-26 is \$1.82 billion, representing an increase of 174.1% over the revised estimate for 2024-25. Such an increase is mainly due to the conduct of the 2025 Election Committee Subsector By-elections and the 2025 Legislative Council General Election. The expenses for the 2 elections have amounted to over \$1.53 billion. Please advise of the allocation of such expenses.
- (2) The revised estimate of election expenses for 2024-25 is \$400 million, yet no election has been conducted during the year. What are the purposes of the election expenses concerned?
- (3) The estimated expenditure of salaries under personal emoluments for 2025-26 exceeds \$190 million, representing an increase of more than 9% over the revised estimate for 2024-25. In light of the civil service pay freeze, what are the reasons for such an increase? According to paragraph 3 under the analysis of recurrent expenditure, the establishment of the REO as at the end of March 2025 will be 320 posts. It is expected that there will be a net decrease of 4 posts in 2025-26. In this regard, why is there an increase, rather than a decrease, in the estimated expenditure for salaries?

Reply:

The provision for 2025-26 under the Registration and Electoral Office for the preparation and conduct of the 2025 Election Committee Subsector (ECSS) By-elections is about \$233 million and the provision for the preparation and conduct of the 2025 Legislative Council General Election (LCGE) is about \$1.28 billion (including the provision for the preparation and conduct of the 2025 voter registration cycle and relevant work).

2. Although 2024-25 is not an election year, the REO still has to carry out various election-related work, including the follow-up work of the 2023 District Council Ordinary

Election, preparation and conduct of the annual voter registration cycle and relevant work, and advanced preparation of part of the work for the two elections in 2025, etc.

3. The provision for personal emoluments of the REO for 2025-26 is higher than the revised estimate for 2024-25. This is mainly due to the filling of some vacancies not until the later part of 2024-25, and thus the revised estimate for 2024-25 cannot reflect the full-year salary expenditure for those posts, in addition to the anticipated increase in expenditure for 2025-26 arising from salary increments of civil servants.

4. As at 31 March 2025, the REO's establishment consists of 320 posts, and it is anticipated that 2 additional civil service posts (including 1 Senior Systems Manager and 1 Systems Manager posts) will be created in 2025-26. After discounting 6 posts to be deleted in 2025-26 (including 1 Executive Officer I, 3 Assistant Clerical Officer, 1 Clerical Assistant and 1 Office Assistant posts), the REO's establishment will gradually reduce to 316 posts in 2025-26, resulting in a net decrease of 4 posts. After the change in the number of posts, there will be a net increase of \$548,040 in the notional annual mid-point salary value because the mid-point salaries of the newly created posts are higher than those of the deleted posts.
